2. INFORMATION CENTRES

2.1. Technical Information Centre (TIC)

The Technical Information Centre is located by the warm-up area.

Teams - Competition Information



The main task of the TIC is to ensure a smooth liaison between each Member Federation and the LOC, the World Athletics Technical Delegates, and the Competition Management of the Championships regarding technical matters.

From 25 August a Virtual TIC will be operating too and will cover all the main tasks of the TIC. Team Leaders will receive a link and credentials to access the service.

Virtual TIC will also provide all information normally shared by TIC in a dedicated section for downloads. It will also be possible to send general inquiries, withdrawal forms, doping control requests and written appeals.

The TIC is responsible for, but not limited to, the following:

- Displaying on the relevant notice board of official communications to the teams, including Start Lists and Results and Call Room reporting times will also be displayed at the Warmup Area
- Distribution of urgent notices to the delegations from the Technical Delegates and Competition Management; it is the Team Leader's duty to report regularly to the TIC to collect this kind of information
- Receipt of written questions for the Technical Briefing, which will follow the Team Leaders tour (deadline 25th August, 18:00)
- Assistance on Final Confirmation
- Receipt of Withdrawal Forms
- Managing National Record Doping Control requests
- Written Appeals
- TIC General Enquiries

The Virtual TIC platform will provide the Team Leader with the above information and give also the option to submit the mentioned forms, appeals and inquiries.

The TIC will be the main centre for technical information, although certain documents produced in the TIC will also be distributed to the Championships Information Desks (CID) for circulation. All the above communications and information will be available on the Online TIC platform as well.

- It will also be possible to submit general enquiries to the TIC through these CIDs.
- Distribution of information and answering queries relating to accommodation, meals, transport and the Championships in general.

2.4 Document Distribution and Support Desks

Document Distribution

Sustainability is a key commitment for WU20 Lima 24 and together we are trying to do our part providing information as paperless as possible.

World Athletics has established a Virtual TIC to reduce the amount of printed material distributed to the Teams at the TIC at the Stadium or at the CID at the Team Hotels

Team Leaders are also strongly encouraged to download the WhatsApp application. In practice this means that the distribution of competition related information at the TIC and CID will not be made through printouts but will be distributed via the Virtual TIC, displayed on the notice boards (also available at the Warm-up Area) and (for the more urgent matters) sent by WhatsApp group to the Team Leaders (their mobile number must be entered in Event Entry System).

Important notices (e.g., changes to the timetable) will also be distributed via the Virtual TIC and displayed on the Posting Board while individual communications to specific teams will be posted at the TIC and sent by e-mails.

3. COMPETITION FACILITIES, EQUIPMENT AND IMPLEMENTS

3.1 Main Stadium

The Championships will take place at Estadio Atlético de la VIDENA.

The part of each spike which projects from the sole or the heel will not exceed 9mm on the track and 12mm for High Jumpers. Needle spikes must not be used on the Mondo track surface.

3.2 Warm-up / Training track

The warm-up area is situated in the same building as the main stadium of the Championships. It will be equipped as follows:

Implements, equipment (hurdles, starting blocks, shots and relay batons will be available to athletes and coaches at the official training venue. These can be obtained from the equipment storage. Athletes/coaches using the equipment will be asked to leave their accreditation card with the LOC representative in charge and the badge will be handed back when the equipment is returned.

3.3 Training schedule

Athletes will not be permitted to use their own markers or tape measure during the Championships. Athletes who wish to use a marker or tape measure must use those provided by the LOC. These are available at the event site.

Additional Implements may be added to the list, if requested by Member Federations directly or by Manufacturers with the endorsement of a Member Federation, by 30 April 2024, and if supplied to the LOC free of charge. All such implements must have World Athletics certification and must be approved by the Technical Delegates. Six items of each implement model must be supplied by the Member Federation or Manufacturer concerned and must be sent to the LOC by 31 July 2024 at the latest.

Personal Implements will also be allowed, providing that:

- they are readily identifiable and are World Athletics certified
- they have been checked for compliance with World Athletics Rules
- they are made available to all other athletes until the end of the Final of the event

In order to speed up the checking in of eligible personal implements, please come prepared and consult the approved list on the website (https://www.worldathletics.org/about-iaaf/documents/technical-information) in advance to identify the implement noting its certification number.

If you do not find your implement in the list but you believe that it is/was certified, please contact the World Athletics office at <u>technicalofficer@worldathletics.org</u> so that its status can be checked and confirmed to you and the LOC in due time. Personal implements that are not identifiable or cannot be confirmed will not be accepted.

4 ELIBILITY, ENTRY RULES, AGE REQUIREMENTS, ENTRY STANDARDS AND CONDITIONS, FINAL ENTRIES AND FINAL CONFIRMATIONS

4.1 Eligibility

The burden of proving that an Athlete is eligible to compete in the World U20 Championships rests with the Member Federation and the Athlete concerned. World Athletics will not accept an entry to the World U20 Championships unless it is satisfied in its absolute discretion that sufficient credible evidence has been provided that the Athlete is eligible to compete.

For the avoidance of doubt, the decision by World Athletics not to accept an Athlete's entry to the U20 World Championships shall be without prejudice to the Athletics Integrity Unit's right to investigate and prosecute any breach of the Integrity Code of Conduct under the Athletics Integrity Unit Reporting, Investigation and Prosecution Rules (Non-Doping) and the Disciplinary and Appeals Tribunal Rules.

4.2 Entry Rules

 A maximum of two athletes from any one Member can compete in each event (with the exception of the Relays).

- Three athletes can initially be entered per event, provided each has achieved the Entry Standard, but only two will be allowed to compete.
- Members who have no male and/or female qualified athletes whom they wish to enter in any Championships event, may enter one unqualified male athlete OR one unqualified female athlete in one event of the Championships (except the Field Events (see below), Combined Events, 5000m and 3000m Steeplechase).
- Members who have no male and/or no female qualified athlete but whose best athlete excels in a Field Event, may submit to World Athletics, by the time of the Preliminary Entry deadline, the name of their athlete plus performance they would like to enter in the Field Event. The Technical Delegates will make the final decision and, to do so, may seek the opinion of the relevant Area Association.
- If the host country of the World U20 Championships does not have an athlete qualified in an event, it may enter one athlete in these events regardless of any entry standard.
- Every Member may enter one team for each relay race, composed by a maximum of six athletes. Any four athletes among those entered for the competition, whether for the relay or for any other event, may then be used in the composition of the team for the first round.

4.3 Age Requirements

- U20 Athletes: any athlete aged 18 or 19 years on 31 December 2024 (born in 2006 or 2005) may compete in any event.
- U18 Athletes: any athlete aged 16 or 17 years on 31 December 2024 (born in 2008 or 2007)
 may compete in any event. However, the maximum number of events in which an U18 athlete
 can compete is two individual events plus one of the relays or two relays only.. If the two
 individual events are Track Events, only one of these may be longer than 200m.
- Athletes Younger than 16: no athlete younger than 16 years of age on 31 December 2024 (born in 2009 or later) may be entered.

Conditions for Validity of Performances

- All performances must be achieved during the period 1 October 2023 to 4 August 2024.
- All performances must be achieved during an official competition organised or authorised by World Athletics, its Area Associations or its Member Federations, conducted in conformity with World Athletics Rules and for which an application has been submitted in advance through the Global Calendar Platform.
- Performances achieved in mixed competitions in track events will not be accepted.
 Exceptionally, in accordance with Rule 9 of the Technical Rules, performances achieved in events of 5000m may be accepted in circumstances where there were insufficient athletes of one or both genders competing to justify the conduct of separate races and there was no pacing or assistance given by an athlete(s) of one gender to an athlete(s) of the other gender. In this case, a specific request must be submitted to World Athletics before the end of the qualification period. For Race Walks the results will always be accepted.
- Wind assisted performances (over 2m/sec) will not be accepted.
- Hand-timed performances for events up to and including 800m will not be accepted.
- Short track performances will be accepted (including indoor).
- For the running events of 200m and over, performances achieved on over-sized tracks will be accepted.
- For Race Walks:
 - o road performances will be accepted.
 - o results of races conducted using the penalty zone will be accepted.

4.5 Final Entries

Final Entries must be submitted online using the World Athletics Event Entry System (EES), by 12 August 2024 midnight, Monaco time. Final Entries may be submitted starting 13 July 2024.

4.6 Final Confirmations

Final confirmations (including Relays) must be done by Member Federations using the Online Confirmation tool on the <u>Virtual TIC (V-TIC) platform</u> as follows (Lima time):

- General
 - Events on the first day: before 12:00 (noon) on 26th.
 - Events on subsequent days: before 09:00 the day before the event

- Relays
- o 4x400 Mixed Relay before 18:00 on 26th
- o 4x100 M&W and 4x400 M&W before 18:00 on 29th

Confirmation of running order must be done before the first call at gathering point only for the first heat of the event

4.7 Athlete Agreement

Each athlete aged 18 or over competing in a World Athletics Series Event must have signed the Athlete Agreement electronically. To do so, Member Federations are required to enter in the EES the individual e-mail address of each participating athlete from their team beforehand. If on the EES an athlete is indicated as having already signed their Athlete Agreement electronically then there is nothing more to do.

For athletes aged 18 or over who have not signed electronically, World Athletics will directly e-mail each athlete to sign their Athlete Agreement electronically. World Athletics will send specific instructions concerning the electronic signature process separately.

For under 18 athletes a separate email will be sent separately to Team Leaders and Member Federations to arrange signature by the under 18 athlete's parent or legal guardian for return by email.

The Athlete Agreement must be signed by no later 14 August 2024 (two days after the Final Entry deadline, 12 August 2024).

If an athlete or Member Federation experiences any issue with the process, they should contact athleteagreement@worldathletics.org. Please note that paper forms of the Athlete Agreement will NOT be collected on site except for Athlete Agreements concerning under 18s.

5. COMPETITION PROCEDURES

5.1 Familiarization visit and training with Starters

Teams

Athletes will have the opportunity train at the competition track on Monday 26th from 09:30 to 11:30, which will them the chance to familiarise themselves with the location of the various facilities.

Official training with the Starters will be from 09:45 to 11:15.

5.2 Orientation Visit for Team Leaders and Coaches

Team Leaders and coaches may visit the Stadium of the Villa Deportiva Nacional (VIDENA), inspecting access routes and other facilities which will be important to the teams on Monday 26th August at 10:00. Please check the notice boards in the hotels for details.

They should meet LOC members at the TIC, from where they will be escorted on this visit

5.3 Technical Delegates Availability

There will not be an official Technical Meeting. However, the Technical Delegates, together with

staff from the LOC and World Athletics Competition Department, will be available after the orientation tour to answer any questions or give any clarification that may be required. Medical/Anti-doping/Safeguarding briefing will follow.

5.4 Timetable

The timetable can be found in appendix and also published on https://worldathletics.org/competitions/world-athletics-u20-championships/lima24/timetable

Information on any changes to the official timetable will be provided through the V-TIC and WhatsApp group.

5.5 Athletes' Bibs

The bibs will be distributed during the administrative procedure at the WA / LOC office in the Jose Antonio Delux Hotel. Bibs which are not collected, will be taken to the Stadium TIC.

All athletes will receive three bibs with their name to be wear as follows:

- One bib on the front and one bib on the back of the competition vest
- One bib to be used for the tracksuit or the bag

Every athlete must wear two bibs during the competition, except in all jumping events, that athletes can decide to wear only one bib on the front or on the back.

Race Walk athletes will receive a number bib that they need to wear on the back.

The bibs with the name for the track events will be distributed in the call room. Those bibs will include transponders.

The bibs for the relays (carrying the country code – (e.g. PER) will be handed out at the call room and placed on the back.

Special bibs (light blue background) shall be used for the leader of the combined events after each event. These shall be handled directly by the Combined Events Referee and distributed at the combined events rest area.

The World Leading Performance Athlete will wear also a special bib with orange background.

Bibs must be worn in accordance with World Athletics Rules and must not be cut, folded or obscured in any way. Failure to comply with the Rules may result in a disqualification or sanction.

5.6 Team Kit

All national team kits (i.e., whether Member Federations have a national sponsor on their national team kit or not) must be submitted via the online form. If you have completed the form to cover all WAS Events in 2024 then there is no action required. If you have not then please complete for the form by 12 August 2024 (the Final Entry deadline).

Please complete the online kit approvals form and remember to upload images / photos of the kit when completing the form. Further information about the national team kit was provided in Circular M/04/24 dated 23 January 2024.

Please contact kitapprovals@worldathletics.org with any questions.

Please note that where World Athletics approve the kit (including any accessories), it is on the condition and expectation that the athletes will wear that same approved kit (including any accessories) issued by Member Federations to their athletes. Member Federations must remind their athletes that if they wear any other kit (including accessories) (e.g., personal kit), then all logos (including the brand) on that kit may either be taped over or the athlete may be instructed by any official (not just the Call Room officials) to remove the accessory or take other action so that the logo(s) on their kit is (are) not visible.

Any infringement of the regulations may result in disciplinary action against the Member Federation and/or individual athlete. Athletes not wearing their official team uniform will be required to change <u>before</u> they progress through the Call Room.

Any infringement of the Rules may result in the disqualification of the athlete. Athletes not wearing their official team uniform will be required to acquire the correct attire <u>before</u> they progress through the Call Room.

5.7 Personal Belongings

In all track events, athletes are supposed to leave the Call Room ready to compete. Their belongings will be taken directly to the Post Event Area. In case of a bad weather, athletes will be allowed to take off their tracksuits at the start. Such later decision will be communicated to the Teams via the WhatsApp group.

Field Event athletes (including Combined Events) will only be permitted to take a backpack or similar sized bag with them into the Field of Play. Combined Events athletes may bring larger bags but they must be left in the rest area during the events.

A strict inspection will be made on illegal and prohibited items, which athletes may have in their possession. Radios, CD/MP3 players, mobile phones, cameras, markers, tape measure, etc. shall not be permitted.

Any items that do not conform to the WA technical and/or advertising Rules and Regulations will be confiscated. (Branding on Drink Bottles, Towels) Confiscated items may be retrieved at the TIC after the event.

5.8 Call Room Procedures

The Call Room shall be located between the warm-up area and the main stadium. All athletes must present themselves to the call room according to the scheduled times as noted below. Times will also be announced over the PA system as well as shown on the electronic display in the warm-up area.

Athletes who fail to appear on time at the reporting point without a valid reason may be excluded from participating in this and all further events in the Championships, including relays. Team Officials are NOT allowed to enter the call room.

Call Room indicative Reporting Times – all times are prior to the actual starting time of the event:

Event	First Entry to Call Room	Last Entry to Call Room	Arrival at Competition Site
Track Events	35 min	25 min	10 min
High Jump	65min	55min	40min
Pole Vault	85 min	75 min	60 min
Other Field Events	55 min	45 min	30 min

Note: Times may change slightly depending on the number of entries and changes will be displayed at TIC and CID.

A dedicated, event by event, heat by heat call-up schedule will be issued once final entries are confirmed and distributed to teams

This will be displayed at the warm-up area and Team Hotels, on V-TIC and shared on the Team Leaders' WhatsApp group.

The procedures in the call room shall be as follows:

- Identification of athletes by means of their accreditation card and bib.
- Checking of athletes' uniform
- Inspection of personal belongings
- Checking of shoe spikes (number, shape and size). The part of each spike which projects from the sole or the heel will not exceed 9mm and 12mm for High Jumpers. Needle spikes must not be used on the Mondotrack surface. If they do not comply, the athletes will be asked to change them to the correct size.

After completion of these procedures, athletes must follow the instructions given by the officials at the call room before being escorted onto the Field of Play.

Athletes who compete in combined events shall report to the reporting point only for the first event of each day. For the first event of the day, the above reporting times apply. As time allows, between events they will be escorted back to the combined events rest areas, from where the Combined Events Referee will manage movement to subsequent events. Precompetition checks will take place in the Combined Events Rest Room Areas before the start of each event.

WA shall provide one Combined Events Rest Room pass per athlete (for coach or physiotherapist)

Team Leaders must ensure that all their athletes comply with the above before entering the call room to avoid delays.

5.9 Athletic Shoes

Only Athletic Shoes complying with the Athletic Shoe Regulations may be worn in competition. The Regulations can be downloaded from the <u>Book of Rules</u> section on the World Athletics website under "Book C: Competition". It is the responsibility of the athlete to know the model they are wearing and to make sure that this model is approved for the specific discipline the athlete is competing in. Athletes are strongly encouraged to check before competition if their shoes are on the List of Approved Athletic Shoes for the specific discipline: https://certcheck.worldathletics.org.

Being a World Athletics Series Event, in accordance with the Athletic Shoe Regulations, no Development Shoes may be worn.

Random shoe check will be carried out within the Post Competition Procedures. Thus, unless otherwise directed by the Referee, the athlete must always keep their Athletic Shoes in their possession until any Post Competition Procedures have been completed.

Any athlete not complying with the Athletic Shoe Regulations may be subject to the sanctions set out in the Regulations, which may include, amongst others, the athlete to be disqualified.

5.10 Track Events

The starter's commands will be given in English.

There are no athlete entrances or special entrance gates. All introductions for heats, semifinals and finals will take place at the blocks or on the start line.

5.11 Field Event Trials

Twelve athletes will normally compete in the Final of all Field Events. In Horizontal Jumps and Throws, the competing order for the fourth and fifth rounds of trials will be in reverse ranking order recorded after the first three rounds of trials. A further re-ranking will take place after the fifth round, so that athletes compete in reverse ranking order in the final round of trials.

There are no athlete entrances or special entrance gates. All introductions for finals will take place at the competition site. There are no line up's or athlete introductions for qualification.

5.12 Coaching Zones

Field Event Coaches will be given access to dedicated coaching zones on the tribunes. Coach passes will be distributed at the TIC to those coaches whose athletes are actually competing and will be checked against the start list. They will be asked to leave their ID (or any other personal identification card) and their document will be handed back when the pass is returned.

5.13 Timing and Measurement

Official timing and measurement will be provided by SEIKO. Video Distance Measurement (VDM) and Electronic Distance Measurement (EDM) will be used as the official measurement system to determine the results in the horizontal jumps and for throwing events respectively. All trials of all athletes are recorded and stored in the system.

5.14 Post Competition Procedures

All athletes will leave the Field of Play via the Mixed Zone situated to the right of the finish line.

In the Mixed Zone, the Media may conduct short interviews. Please note that the first three athletes in each Final may also be required to attend the formal interview.

Athletes will then reach the Post Event Area located where the clothing baskets will be taken from the Call Room.

Transponders from the athletes' bibs will be collected here by Seiko. Those progressing to the following round (where applicable) will keep their bib and the transponders will be inserted again in the Call Room before the race in the following round.

Member Federation will be charged 150USD per transponder that is not returned by the athlete.

Here athletes will also be notified for eventual doping control and be informed of medal ceremony arrangements. From here they can then return to the Warm-up Area, Team seats or Team hotel.

5.15 Medal Ceremonies

Medallist will receive their medals inside Stadium La VIDENA.

The first, second and third placed athletes in each individual event and the first three teams in each relay race will be presented with a gold, silver and bronze medal respectively.

If a team competes in the relay final with different athletes to the first round, only the four athletes in the final will be awarded medals during the official ceremony. The other athletes will be able to collect their medals later from the Technical Information Centre (TIC).

Where medal ceremonies are held during the same session as the respective competition, the ceremony will usually take place before doping control procedures and possibly before the athletes have completed media commitments.

LOC staff will gather the placed athletes or relay teams and escort them to the Medal Ceremonies Preparation Room, via kit collection, where they will be briefed and wait for the ceremony.

For medal ceremonies taking place during the following session or day, medallists will receive an information sheet in post event control which will indicate the time and location they need to report to the following day, from which they will be escorted to the Medal Ceremonies Holding Area. Team Management will also be notified of any relevant medal ceremony instructions

Athletes must wear their Member Federation's official presentation kit/uniform for medal ceremonies. For medal ceremonies taking place during the same session, where possible, official presentation kit/uniform should be brought in the athlete's bag. If an athlete that wins a medal does not have their official presentation kit/uniform in their bag for the ceremony, team officials should take the athletes official uniform directly to the TIC contact desk. Team officials must notify the TIC in writing if the athlete cannot attend a medal ceremony and give the reason for their non-attendance (e.g. emergency, medical, circumstances beyond their control). Watches are not permitted to be worn at medal ceremonies.

During the playing of the anthem, digital flags will be displayed on one screen and medallist shall turn 90 degrees to the left or right to face the flags and conduct themselves in a dignified manner at all times.

Medallists will not be permitted to bring a national flag nor any other items to the ceremony.

After medal ceremonies have taken place, medallists will be escorted back to the Medal Ceremonies Preparation Room.

Where the medal ceremony has taken place during the same session as their event, athletes will then be escorted back to the point of the mixed zone or post event control where they were first escorted from.

Where the medal ceremonies have taken place during the following session or day, athletes will be escorted back to the initial reporting location. Athletes will be permitted to bring one member of Team Management with them to the Medal Ceremonies Holding Area.

5.16 Protests and Appeals

Protests and Appeals will be handled according to Rule 8 of the Technical Rules. Protests and appeals will be handled by the TIC at La VIDENA.

5.16.1 Protests

Protests concerning the result or conduct of an event shall be made within 30 minutes of the official announcement of the result of that event. The Organising Committee of the competition shall be responsible for ensuring that the time of the announcement of all results is recorded.

Any protest shall be made verbally to the referee, by an athlete, by someone acting on his behalf or by an official representative of a team. Such person or team may protest only if they are competing in the same round of the event to which the protest (or subsequent appeal) relates. To arrive at a fair decision, the referee should consider any available evidence which he thinks necessary, including a film or picture produced by an official video recorder, or any other available video evidence. The referee may decide on the protest or may refer the matter to the jury.

If the referee makes a decision, there shall be a right of appeal to the jury. Where the referee is not accessible or available, the protest should be made to them through the Virtual TIC.

5.16.2 Appeals

An appeal to the Jury of Appeal must be made using the Virtual TIC platform within 30 minutes:

- of the official announcement of the amended result of an event arising from the decision made by the referee; or
- of the advice being given to those making the protest, where there is no amendment of any result.

It shall be in writing, signed by a responsible official on behalf of the athlete or team. In case of appeals lost, the US\$ 100 fee will be deducted by World Athletics from the Member Federation's account.

Note: The relevant referee shall, after his decision on a protest, immediately inform the TIC of the time of the decision. If the referee was unable to communicate this verbally to the relevant team(s) /athlete(s), the official time of the announcement will be that of the posting of the amended results or of the decision at the TIC.

Athletes confirm that they will make themselves available to World Athletics for promotional activities as set out in the athlete agreement.


